We [Adel, Kim & I] had a stream in front of our cabin. Rather than being quiet, the rocks in the stream caused the water to make a lot of splashing noises. It is unfortunate that some people have been able to buy yudansha grade certificates, have printed their own & "created" signatures, or have even sent letters to other organizations (in lieu of cetificates | with a forged signature.

Fortunately organizations to communicate quite quickly and effectively in this area when questions arise -- because it affects the integrity of the entire martial arts community. In effect we police ourselves to maintain our integrity.

What happens when certification is denied. It hurts the entire martial arts community because it hurts our integrity.

What does it to do the persons involved in the deception? It destroys their integrity because all of the reputable martial arts organizations and sensei involved become aware of the persons' indiscretion.

Page 249: BUDOSH(N (not "BODOSHIN") Ju-Jitsu


Page 252, 3rd line: are nine (not "six") Ude Guruma...
